1. INTRODUCTION

To provide the best functioning of EAH TRADING, we collect personal data automatically through cookies. Here you will find objective information about what cookies are, what cookies we use, what role they play and how to contain them.

2. WHAT ARE COOKIES?

Cookies are small text files that a website, when visited, places on the user's computer or on their mobile device, through the internet browser (browser).

The placement of cookies will help the website to recognize your device on a next visit. We use the term cookies in this policy to refer to all files that collect information in this way.

The cookies used do not collect information that identifies the user, however, if you are already on our website we can monitor your visits to the site provided that, at least, for once, you have started your navigation from some communication sent by us, for example, SMS and email.

Cookies also collect generic information, such as how users arrive and use the websites or the area of the country/countries through which they access the website, etc. Cookies retain only information related to your preferences. At any time the user may, through his internet browser (browser) decide to be notified about the reception of cookies, as well as block the respective entry into his system. The refusal to use cookies on the website may result in the impossibility of having access to some of its areas or of receiving personalized information.

Cookies are used to help determine the usefulness, interest and number of uses of websites, allowing for faster and more efficient navigation and eliminating the need to repeatedly enter the same information.

3. WHAT ARE COOKIES FOR?

4. TYPES OF COOKIES

The cookies used by EAH TRADING have the following characteristics:

4.1 ESSENTIAL COOKIES

Some cookies are essential to access the specific areas of our website. They allow navigation on the site and the use of its applications, such as accessing secure areas of the site through login. Without these cookies, services that require it cannot be provided.

4.2 ANALYTICAL COOKIES

We use these cookies to analyse how users use the website and monitor its

performance. This allows us to provide a high-quality experience by customizing our offer and quickly identifying and correcting any issues that arise. For example, we use performance cookies to know which pages are most popular, which method of linking between pages is most effective, or to determine why some pages are receiving error messages. Based on the use of the website, we may also use these cookies to highlight articles or services on the website that we think may be of interest to users. These cookies are used only for the purpose of statistical creation and analysis, without ever collecting personal information.

4.3 THIRD PARTY COOKIES

They serve to measure the success of applications and the effectiveness of third-party advertising on our website.

4.4 ADVERTISING COOKIES

They serve to target advertising according to the interests of each user and the number of visits they have made, allowing to limit the number of times the ad is displayed. These cookies help measure the effectiveness of advertising.

5. COOKIE MANAGEMENT

The use of cookies is necessary for navigation on the EAH TRADING website. Therefore, if you do not allow them, they may cause losses in the performance of navigation. The first time you access our applications, you will be asked if you agree to the use of cookies. Only after their acceptance will they be activated.

The cookies used can be:

5.1 PERMANENT COOKIES

They are stored at the level of the internet browser (browser) on your access devices (Computer, mobile and tablet) and are used whenever the user makes a new visit to the site. They are generally used to direct navigation according to the interests of the user, allowing us to provide a more personalized service.

5.2 SESSION COOKIES

They are temporary, remain in the cookies of your internet browser (browser) until you leave the site. The information obtained allows you to identify problems and provide a better browsing experience.

After authorizing the use of cookies, the user can always disable part or the all of our cookies.

All browsers allow the user to accept, refuse or delete cookies, namely by selecting the appropriate settings in the respective browser. You can set cookies in the "options" or "preferences" menu of your browser.

It should be noted that by disabling cookies, you can prevent some web services from working properly, affecting, in whole or in part, the navigation on the website.

We remind you that by disabling cookies, parts of our website may not function properly.
